Successful apprentices will gain valuable work experience needed to get hired and may have the opportunity to join the CIF team or one of its portfolio companies full-time. Apprentices can expect to work 15-25 hours per week at the CIF offices, remotely, and offsite at events and meetings.

About you - Prior work experience is optional, but passion, enthusiasm, and commitment are definitely required. If you're the ideal candidate, then you're as passionate about our mission as we are, you're entrepreneurial, and able to work independently in an unstructured environment where initiative, creativity, maturity and enthusiasm for learning are highly valued. Roles & Responsibilities - A CIF Apprenticeship isn't like an internship where you're going to sit around and watch other people work. You're going to get your hands dirty. You're going to be handed assignments that you'll need to figure out how to complete on your own. You'll own projects and will probably be responsible for directing others and making sure they deliver. You'll be thrown in the deep end of the pool and you'll sink or swim. When you sink, you'll need to quickly understand why, learn from it, and move on. Assignments may include:

- Research & Analysis - perform market research, analyze and interpret data, and apply to make recommendations or decisions on market opportunities, products, competition, strategy, and more.
- Business Administration - form new companies, establishing and owning business processes for accounting, finance, sales, marketing, business development, operations, and more.
- Reports, Presentations, and Proposals - outline, draft, and edit deliverables for prospective and active client engagements
